Shetland Sheepdog Herding Fun Day!

Event Details:

This Fun Day will consist of a brief explanation of the basics of herding; the fundamental concepts of training; and a demonstration of the basic training steps.

Bettie will then give each novice dog individual exposure to the stock, and an informal instinct evaluation.

Following will be a discussion of the AKC Test Classes, HT (Herding Tested) & PT (Pre-Trial), as well as the Herding Trial Classes. During this discussion, dog/handler teams with herding experience may demonstrate the skills needed for the Test and Trial Classes.

This event is intended to be a fun, relaxed introduction to herding; it will not be a formal Herding Clinic.

- Fee: \$20.00 per working dog for GSLSSC Members; \$40.00 for non-members
- All level of dogs/handlers welcome
- Auditors, spectators encouraged (no fee).
- Event is limited to 15 working dogs.
- Reservations for working slots are on a "First Received" basis with preference given to Shetland Sheepdogs owned by GSLSSC members who register before February 15, 2020, after which time registration will be open to all Shetland Sheepdogs.
- Start time: 9:00am
- Lunch will be provided by GSLSSC.

Participants should bring a side dish or dessert to share.

Please bring you own drinks; lawn chairs, and water for your dog.

You may also want to bring a shade umbrella or similar item.

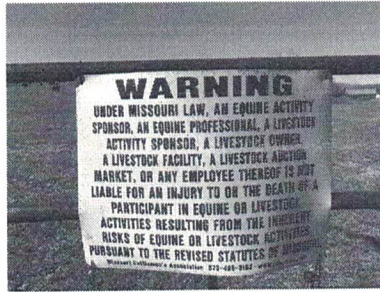
